

# SYNERGY WINDOWS & MORE – FIFA WORLD CUP VIP GIVEAWAY

## OFFICIAL TERMS AND CONDITIONS

---

### 1. SPONSOR

The Synergy Windows & More FIFA World Cup VIP Giveaway (the “Promotion”) is sponsored by **Synergy Windows & More** (“Sponsor”). This Promotion is not sponsored, endorsed, administered by, or associated with Instagram, Meta, FIFA, or any of their affiliated entities.

### 2. ELIGIBILITY

The Promotion is open only to legal residents of the State of Florida who are **eighteen (18) years of age or older** at the time of entry and who reside in **Broward County, Miami-Dade County, Palm Beach County, or Monroe County**.

Employees, contractors, officers, and directors of Sponsor, as well as their immediate family members and household members, are not eligible to participate.

### 3. PROMOTION PERIOD

The Promotion begins on **01/20/2026** and ends on **05/31/2026** (the “Promotion Period”). Entries submitted before or after the Promotion Period will not be eligible.

### 4. HOW TO ENTER

Participants may earn entries by completing one or more actions listed on the official **Gleam giveaway landing page**, including but not limited to:

- Submitting a Google or Facebook review
- Confirming existing Synergy customer status

- Following, liking, reposting, and tagging on Instagram
- Uploading video testimonials
- Uploading proof of closed contracts completed between January and May

Entries are awarded based on weighted actions as described on the Glean landing page. Completing additional actions increases the number of entries and the chance of winning. All entries are subject to verification by Sponsor.

## 5. PRIZE DETAILS

One (1) **Grand Prize Winner** will receive:

- Two (2) VIP tickets to a **FIFA World Cup Third Place Play-Off Match in Miami**

## 6. TRANSPORTATION TERMS

Transportation services will be provided **only** for winners residing in:

- **Broward County**
- **Miami-Dade County**

Participants residing in **Palm Beach County or Monroe County** remain eligible to enter and win the Promotion; however, **transportation will not be provided** for winners residing outside of Broward or Miami-Dade counties.

All transportation details, including pickup location, timing, and service provider, shall be determined solely by Sponsor.

## 7. WINNER SELECTION AND NOTIFICATION

The winner will be selected at random using **Gleam's automated winner selection system** from among all eligible entries received.
